HOW TO ENTER: NO PURCHASE NECESSARY. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. This Sweepstakes begins at 12:00:00 AM Eastern Time (“ET”) on March 1, 2019 and ends at 11:59:59 PM (ET) on April 30, 2019 (“**Sweepstakes Entry Period**”). You may enter this Sweepstakes by visiting the UGI Advantage page (<https://www.ugiadvantage.com>) and enrolling for any UGI Advantage Service Agreement plan. By enrolling for the UGI Advantage Service Agreement plan, you will be automatically entered to win the Grand Prize in accordance with these Official Rules. All current customers with an active UGI Advantage Service Agreement plan as of April 30, 2019 will be automatically entered to win.
